# EXISTENCE OF A SOLUTION FOR A CLASS OF NONLINEAR PARABOLIC SYSTEMS

#### Abstract

An existence result of a solution for a class of nonlinear parabolic systems is established. The data belong to $L^{1}$ and no growth assumption is made on the nonlinearities.


## 1. Introduction

In the present paper we establish an existence result of a renormalized solution for a class of nonlinear parabolic systems of the type

In Problem (1.1)-(1.5) the framework is the following : $\Omega$ is a bounded domain of $R^{N},(N \geq 1), T$ is a positive real number while the data $u_{0}$ and $v_{0}$ in $L^{1}(\Omega)$. The operator $-\operatorname{div}(a(x, u, D u))$ is a Leray-Lions operator which is coercive and which grows like $|D u|^{p-1}$ with respect to $D u$, but which is not restricted by any growth condition with respect to $u$ (see assumptions (2.1), (2.2), (2.3) and (2.4) of Section 2.). The function $\Phi, f_{1}$ and $f_{2}$ are just assumed to be continuous on $\mathbb{R}$.

When Problem (1.1)-(1.5) is investigated there is difficulty is due to the facts that the data $u_{0}$ and $v_{0}$ only belong to $L^{1}$ and the function $a(x, u, D u), \Phi(u)$, $f_{1}(x, u, v)$ and $f_{2}(x, u, v)$ does not belong $\left(L_{l o c}^{1}((0, T) \times \Omega)\right)^{N}$ in general, so that proving existence of a weak solution (i.e. in the distribution meaning) seems to be an arduous task. To overcome this difficulty we use in this paper the framework of renormalized solutions. This notion was introduced by Lions and Di Perna [22] for the study of Boltzmann equation (see also P.-L. Lions [17] for a few applications to fluid mechanics models). This notion was then adapted to elliptic vesion of (1.1), (1.2), (1.3) in Boccardo, J.-L. Diaz, D. Giachetti, F. Murat [10], in P.-L. Lions and F. Murat [19] and F. Murat [19], [20]. At the same time the equivalent notion of

[^0]entropy solutions has been developed independently by Bénilan and al. [2] for the study of nonlinear elliptic problems.

As far as the parabolic equation case (1.1)-(1.5), (with, $f_{i}(x, u, v)=f \in L^{1}(\Omega \times$ $(0, T)))$ is concerned and still in the framework of renormalized solutions, the existence and uniqueness has been proved in D. Blanchard, F. Murat and H. Redwane [5] (see also A. Porretta [21] and H. Redwane [23]) in the case where $f_{i}(x, u, v)$ is replaced by $f+\operatorname{div}(g)$ (where $g$ belong $L^{p^{\prime}}(Q)^{N}$ ). In the case where $a(t, x, s, \xi)$ is independant of $s, \Phi=0$ and $g=0$, existence and uniqueness has been established in D. Blanchard [3] ; D. Blanchard and F. Murat [4], and in the case where $a(t, x, s, \xi)$ is independent of $s$ and linear with respect to $\xi$, existence and uniqueness has been established in D. Blanchard and H. Redwane [7].

In the case where $\Phi=0$ and where the operator $\triangle_{p} u=\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)$
p-Laplacian replaces a nonlinear term $\operatorname{div}(a(x, s, \xi))$, existence of a solution for nonlinear parabolic systems (1.1)-(1.5) is investigated in El Ouardi, A. El Hachimi ( [14] [15]), in Marion [18] and in A. Eden and all [1] (see also L. Dung [12]), where an existence result of as (usual) weak solution is proved.

With respect to the previous ones, the originality of the present work lies on the noncontrolled growth of the function $a(x, s, \xi)$ with respect to $s$, and the function $\Phi, f_{1}$ and $f_{2}$ are just assumed to be continuous on $\mathbb{R}$, and $u_{0}, v_{0}$ are just assumed belong to $L^{1}(\Omega)$.

The paper is organized as follows : Section 2 is devoted to specify the assumptions on $a(x, s, \xi), \Phi, f_{1}, f_{2}, u_{0}$ and $v_{0}$ needed in the present study and gives the definition of a renormalized solution of (1.1)-(1.5). In Section 3 (Theorem 3.0.4) we establish the existence of such a solution.

## 2. Assumptions on the data and definition of a renormalized solution

Throughout the paper, we assume that the following assumptions hold true : $\Omega$ is a bounded open set on $\mathbb{R}^{N}(N \geq 1), T>0$ is given and we set $Q=\Omega \times(0, T)$, for $i=1,2$

For any $K>0$, there exists $\beta_{K}>0$ and a function $C_{K}$ in $L^{p^{\prime}}(\Omega)$ such that

Remark 2.0.1. As already mentioned in the introduction Problem (1.1)-(1.5) does not admit a weak solution under assumptions (2.1)-(2.10) (even when $f_{1}=f_{2} \equiv 0$ ) since the growths of $a(u, D u)$ and $\Phi(u)$ are not controlled with respect to $u$ (so that these fields are not in general defined as distributions, even when $u$ belongs $\left.L^{p}\left(0, T ; W_{0}^{1, p}(\Omega)\right)\right)$.

Throughout this paper and for any non negative real number $K$ we denote by $T_{K}(r)=\min (K, \max (r,-K))$ the truncation function at height $K$. For any measurable subset $E$ of $Q$, we denote by meas $(E)$ the Lebesgue measure of $E$. For any measurable function $v$ defined on $Q$ and for any real number $s, \chi_{\{v<s\}}$ (respectively, $\left.\chi_{\{v=s\}}, \chi_{\{v>s\}}\right)$ is the characteristic function of the set $\{(x, t) \in Q ; v(x, t)<s\}$ (respectively, $\{(x, t) \in Q ; v(x, t)=s\},\{(x, t) \in Q ; v(x, t)>s\})$. The definition of a renormalized solution for Problem (1.1)-(1.5) can be stated as follows.

Definition 2.0.2. A couple of functions $(u, v)$ defined on $Q$ is called a renormalized solution of Problem (1.1)-(1.5) if $u$ and $v$ satisfy :

The following remarks are concerned with a few comments on definition 2.0.2.
Remark 2.0.3. Equation (2.14) (and (2.15)) is formally obtained through pointwise multiplication of equation (1.1) by $S^{\prime}(u)$ (and equation $(1.2)$ by $S^{\prime}(v)$ ). Note that in definition 2.0.2, $D u$ is not defined even as a distribution, but that due to (2.11) each term in (2.14) (and (2.15)) has a meaning in $L^{1}(Q)+L^{p^{\prime}}\left(0, T ; W^{-1, p^{\prime}}(\Omega)\right)$.

Indeed if $K$ is such that supp $S^{\prime} \subset[-K, K]$, the following identifications are made in (2.14) (and in (2.15)) :

* $S(u)$ belongs to $L^{\infty}(Q)$ since $S$ is a bounded function.
$\star S^{\prime}(u) a(u, D u)$ identifies with $S^{\prime}(u) a\left(T_{K}(u), D T_{K}(u)\right)$ a.e. in $Q$. Since indeed $\left|T_{K}(u)\right| \leq K$ a.e. in $Q$, assumptions (2.1) and (2.3) imply that

^ $S^{\prime}(u) \Phi(u)$ and $S^{\prime \prime}(u) \Phi(u) D u$ respectively identify with $S^{\prime}(u) \Phi\left(T_{K}(u)\right)$ and $S^{\prime \prime}(u) \Phi\left(T_{K}(u)\right) D T_{K}(u)$. Due to the properties of $S$ and (2.5), the functions $S^{\prime}, S^{\prime \prime}$ and $\Phi \circ T_{K}$ are bounded on $\mathbb{R}$ so that (2.11) implies that $S^{\prime}(u) \Phi\left(T_{K}(u)\right) \in\left(L^{\infty}(Q)\right)^{N}$, and $S^{\prime \prime}(u) \Phi\left(T_{K}(u)\right) D T_{K}(u) \in L^{p}(Q)$.
$\star S^{\prime}(u) f_{1}(x, u, v)$ identifies with $S^{\prime}(u) f_{1}\left(x, T_{K}(u), v\right)$ a.e. in $Q$. Since indeed $\left|T_{K}(u)\right| \leq K$ a.e. in $Q$, assumptions (2.8) imply that

As a consequence of (2.11) and of $S^{\prime}(u) \in L^{\infty}(Q)$, it follows that

The above considerations show that equation (2.14) takes place in $D^{\prime}(Q)$ and that $\frac{\partial S(u)}{\partial t}$ belongs to $L^{p^{\prime}}\left(0, T ; W^{-1, p^{\prime}}(\Omega)\right)+L^{1}(Q)$, which in turn implies that $\frac{\partial S(u)}{\partial t}$ belongs to $L^{1}\left(0, T ; W^{-1, s}(\Omega)\right)$ for all $s<\inf \left(p^{\prime}, \frac{N}{N-1}\right)$. It follows that $S(u)$ belongs to $C^{0}\left([0, T] ; W^{-1, s}(\Omega)\right)$ so that the initial condition (2.16) makes sense. The same holds also for $v$.

## 3. Existence Result

This section is devoted to establish the following existence theorem.
Theorem 3.0.4. Under assumptions (2.1)-(2.10) there exists at least a renormalized solution ( $u, v$ ) of Problem (1.1)-(1.5).

Proof. of Theorem 3.0.4. The proof is divided into 9 steps. In Step1, we introduce an approximate problem. Step 2 is devoted to establish a few a priori estimates. In Step 3, the limit $(u, v)$ of the approximate solutions $\left(u^{\varepsilon}, v^{\varepsilon}\right)$ is introduced and is shown of $(u, v)$ belongs to $L^{\infty}\left(0, T ; L^{1}(\Omega)\right)^{2}$ and to satisfy (2.11). In Step 4, we define a time regularization of the field $\left(T_{K}(u), T_{K}(v)\right)$ and we establish Lemma 3.0.5, which a allows us to control the parabolic contribution that arises in the monotonicity method when passing to the limit. Step 5 is devoted to prove that an energy estimate (Lemma 3.0.6) which is a key point for the monotonicity arguments that are developed in Step 6 and Step 7. In Step 8, we prove that $u$ satisfies (2.12) and $v$ satisfies (2.13). At last, Step 9 is devoted to prove that $(u, v)$ satisfies (2.14), (2.15) and (2.16) of definition 2.0.2

* Step 1. Let us introduce the following regularization of the data:

In view of (2.3), (2.8) and (2.9), $a_{\varepsilon}, f_{1}^{\varepsilon}$ and $f_{1}^{\varepsilon}$ satisfiy : there exists $C_{\varepsilon} \in$ $L^{p^{\prime}}(\Omega), F_{\varepsilon} \in L^{1}(\Omega), G_{\varepsilon} \in L^{1}(\Omega)$ and $\beta_{\varepsilon}>0, \sigma_{\varepsilon}>0, \lambda_{\varepsilon}>0$, such that

As a consequence, proving existence of a weak solution $\left(u^{\varepsilon}, v^{\varepsilon}\right) \in\left(L^{p}\left(0, T ; W_{0}^{1, p}(\Omega)\right)\right)^{2}$ of (3.6)-(3.10) is an easy task (see e.g. [1], [14] and [15]).

* Step 2. The estimates derived in this step rely on usual techniques for problems of type (3.6)-(3.10) and we just sketch the proof of them (the reader is referred to [3], [4], [7], [9], [5], [6] or to [10], [19], [20] for elliptic versions of (3.6)-(3.10)).

The pointwise convergence of $u^{\varepsilon}$ to $u$ as $\varepsilon$ tends to 0 , the bounded character of $S$, (3.21) and (3.62) of Lemma (3.0.8) imply that

$$
S^{\prime}\left(u^{\varepsilon}\right) a_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right), D T_{K}\left(u^{\varepsilon}\right)\right) \rightharpoonup S^{\prime}(u) a\left(T_{K}(u), D T_{K}(u)\right) \text { weakly in } L^{p^{\prime}}(Q)
$$

as $\varepsilon$ tends to 0 , because $S^{\prime}(u)=0$ for $|u| \geq K$ a.e. in $Q$. And the term

$$
S^{\prime}(u) a\left(T_{K}(u), D T_{K}(u)\right)=S^{\prime}(u) a(u, D u) \text { a.e. in } Q
$$

$\star$ Limit of $S^{\prime \prime}\left(u^{\varepsilon}\right) a_{\varepsilon}\left(u^{\varepsilon}, D u^{\varepsilon}\right) D u^{\varepsilon}$
Since supp $S^{\prime \prime} \subset[-K, K]$, we have for $\varepsilon \leq \frac{1}{K^{\star}}$

$$
S^{\prime \prime}\left(u^{\varepsilon}\right) a_{\varepsilon}\left(u^{\varepsilon}, D u^{\varepsilon}\right) D u^{\varepsilon}=S^{\prime \prime}\left(u^{\varepsilon}\right) a_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right), D T_{K}\left(u^{\varepsilon}\right)\right) D T_{K}\left(u^{\varepsilon}\right) \text { a.e. in } Q .
$$

The pointwise convergence of $S^{\prime \prime}\left(u^{\varepsilon}\right)$ to $S^{\prime \prime}(u)$ as $\varepsilon$ tends to 0 , the bounded character of $S^{\prime \prime}, T_{K}$ and (3.63) of lemma (3.0.8) allow to conclude that

$$
S^{\prime \prime}\left(u^{\varepsilon}\right) a_{\varepsilon}\left(u^{\varepsilon}, D u^{\varepsilon}\right) D u^{\varepsilon} \rightharpoonup S^{\prime \prime}(u) a\left(T_{K}(u), D T_{K}(u)\right) D T_{K}(u)
$$

weakly in $L^{1}(Q)$, as $\varepsilon$ tends to 0 . And

$$
S^{\prime \prime}(u) a\left(T_{K}(u), D T_{K}(u)\right) D T_{K}(u)=S^{\prime \prime}(u) a(u, u) D u \text { a.e. in } Q
$$

$\star$ Limit of $S^{\prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right)$
Since supp $S^{\prime} \subset[-K, K]$, we have for $\varepsilon \leq \frac{1}{K^{\star}}$

$$
S^{\prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right)=S^{\prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right)\right) \text { a.e. in } Q .
$$

As a consequence of (2.5), (3.2) and (3.20), it follows that for any $1 \leq q<+\infty$

$$
S^{\prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right) \rightarrow S^{\prime}(u) \Phi\left(T_{K}(u)\right) \text { strongly in } L^{q}(Q),
$$

as $\varepsilon$ tends to 0 . The term $S^{\prime}(u) \Phi\left(T_{K}(u)\right)$ is denoted by $S^{\prime}(u) \Phi(u)$.

* Limit of $S^{\prime \prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right) D u^{\varepsilon}$

Since $S^{\prime} \in W^{1, \infty}(\mathbb{R})$ with supp $S^{\prime} \subset[-K, K]$, we have

$$
S^{\prime \prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right) D u^{\varepsilon}=\Phi_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right)\right) D S^{\prime}\left(u^{\varepsilon}\right) \text { a.e. in } Q
$$

we have, $D S^{\prime}\left(u^{\varepsilon}\right)$ converges to $D S^{\prime}(u)$ weakly in $L^{p}(Q)^{N}$ as $\varepsilon$ tends to 0 , while $\Phi_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right)\right)$ is uniformly bounded with respect to $\varepsilon$ and converges a.e. in $Q$ to $\Phi\left(T_{K}(u)\right)$ as $\varepsilon$ tends to 0 . Therefore

$$
S^{\prime \prime}\left(u^{\varepsilon}\right) \Phi_{\varepsilon}\left(u^{\varepsilon}\right) D u^{\varepsilon} \rightharpoonup \Phi_{\varepsilon}\left(T_{K}\left(u^{\varepsilon}\right)\right) D S^{\prime}\left(u^{\varepsilon}\right) \text { weakly in } L^{p}(Q) .
$$

$\star$ Limit of $f^{\varepsilon}\left(x, u^{\varepsilon}, v^{\varepsilon}\right) S^{\prime}\left(u^{\varepsilon}\right)$

Due to (2.6), (2.8), (3.3), (3.20) and (3.24), we have

$$
f^{\varepsilon}\left(x, u^{\varepsilon}, v^{\varepsilon}\right) S^{\prime}\left(u^{\varepsilon}\right) \rightarrow f(x, u, v) S^{\prime}(u) \text { strongly in } L^{1}(Q)
$$

as $\varepsilon$ tends to 0 .
As a consequence of the above convergence result, we are in a position to pass to the limit as $\varepsilon$ tends to 0 in equation (3.68) and to conclude that $u$ satisfies (2.14), (and $v$ satisfies (2.15))

It remains to show that $S(u)$ (and $S(v)$ ) satisfies the initial condition (2.16 for $u)$ (and (2.16 for $v$ ). To this end, firstly remark that, $S$ being bounded, $S\left(u^{\varepsilon}\right)$ is bounded in $L^{\infty}(Q)$. Secondly, (3.68) and the above considerations on the behavior of the terms of this equation show that $\frac{\partial S\left(u^{\varepsilon}\right)}{\partial t}$ is bounded in $L^{1}(Q)+$ $L^{p^{\prime}}\left(0, T ; W^{-1, p^{\prime}}(\Omega)\right)$. As a consequence, an Aubin's type lemma (see, e.g, [24], Corollary 4) implies that $S\left(u^{\varepsilon}\right)$ lies in a compact set of $C^{0}\left([0, T] ; W^{-1, s}(\Omega)\right)$ for any $s<\inf \left(p^{\prime}, \frac{N}{N-1}\right)$. It follows that, on one hand, $S\left(u^{\varepsilon}\right)(t=0)=S\left(u_{0}^{\varepsilon}\right)$ converges to $S(u)(t=0)$ strongly in $W^{-1, s}(\Omega)$. On the order hand, (3.5) and the smoothness of $S$ imply that $S\left(u_{0}^{\varepsilon}\right)$ converges to $S(u)(t=0)$ strongly in $L^{q}(\Omega)$ for all $q<+\infty$. Then we conclude that

$$
S(u)(t=0)=S\left(u_{0}\right) \text { in } \Omega .
$$

The same holds also for $v$

$$
S(v)(t=0)=S\left(v_{0}\right) \text { in } \Omega .
$$

As a conclusion of step 3 , step 8 and step 9 , the proof of theorem 3.0.4 is complete.
