Admissibility and nonuniformly hyperbolic sets

Abstract. We obtain a characterization of two classes of dynamics with nonuniformly hyperbolic behavior in terms of an admissibility property. Namely, we consider exponential dichotomies with respect to a sequence of norms and nonuniformly hyperbolic sets. We note that the approach to establishing exponential bounds along the stable and the unstable directions differs from the standard technique of substituting test sequences. Moreover, we obtain the bounds in a single step.

Keywords: exponential dichotomies, nonuniformly hyperbolic sets.

1 Introduction

Our main objective is to obtain a characterization of two classes of dynamics with nonuniformly hyperbolic behavior in terms of an admissibility property. Namely, we consider the class of exponential dichotomies with respect to a sequence of norms and the class of nonuniformly hyperbolic sets.

In the first part of the paper we consider a nonautonomous dynamics with discrete time obtained from a sequence of linear operators on a Banach space and we characterize the notion of an exponential dichotomy with respect to a sequence of norms. The principal motivation for considering this notion is that includes both the notions of a uniform and of a nonuniform exponential dichotomy as special cases. We refer the reader to the books [3,6,7,12] for details and further references on the uniform theory. On the other hand, the requirement of uniformity for the asymptotic behavior is often too stringent for the dynamics and it turns out that the notion of a nonuniform exponential dichotomy is much more typical. We refer the reader to [2] for an account of a substantial part of the theory. Most of the work in the literature related to admissibility has been devoted to the study of uniform exponential dichotomies. For some of the most relevant early contributions in the area we refer to the books by Massera and Schäffer [10] and by Dalec'kiĭ and Kreĭn [4]. We also refer to [9] for some early results in infinite-dimensional spaces. For a detailed list of references, we refer the reader to [3] and for more recent work to Huy [8].

We emphasize that we consider the general case of a noninvertible dynamics which means that we assume only the invertibility along the unstable direction. Moreover, we characterize exponential dichotomies with respect to a sequence of norms in terms of the admissibility of a large family of Banach spaces (the particular case of l^p spaces was considered in [1]). We note that the approach to establishing exponential bounds along the stable and the unstable directions differs from the standard technique of substituting test sequences (see for example [6,8]). Moreover, in contrast to the existing approaches, we are able to obtain bounds along the stable and unstable directions in a single step.

In the second part of the paper we obtain an analogous characterization of nonuniformly hyperbolic sets. The notion of a nonuniformly hyperbolic set arises naturally in the context of smooth ergodic theory. Indeed, if f is a C^1 diffeomorphism of a finite-dimensional compact manifold preserving a finite measure μ with nonzero Lyapunov exponents, then there exists a nonuniformly hyperbolic set of full μ -measure. We refer the reader to [2] for details. Our work is close in spirit to that of Mather [11], who obtained a similar characterization of uniformly hyperbolic sets, as well as that of Dragičević and Slijepčević [5], where the problem of extending Mather's result to nonuniformly hyperbolic dynamics was first considered. However, there are substantial differences between our approach and that in [5], which provides a characterization of ergodic invariant measures with nonzero Lyapunov exponents and not of nonuniformly hyperbolic sets.

2 Preliminaries

In this section we introduce a few basic notions. Let S be the set of all sequences $\mathbf{s} = (s_n)_{n \in \mathbb{Z}}$ of real numbers. We say that a linear subspace $B \subset S$ is a *normed sequence space* if there exists a norm $\|\cdot\|_B \colon B \to \mathbb{R}^+_0$ such that if $\mathbf{s}' \in B$ and $|s_n| \leq |s'_n|$ for $n \in \mathbb{Z}$, then $\mathbf{s} \in B$ and $\|\mathbf{s}\|_B \leq \|\mathbf{s}'\|_B$. If in addition $(B, \|\cdot\|_B)$ is complete, we say that B is a *Banach sequence space*.

Let *B* be a Banach sequence space. We say that *B* is *admissible* if:

- 1. $\chi_{\{n\}} \in B$ and $\|\chi_{\{n\}}\|_B > 0$ for $n \in \mathbb{Z}$, where χ_A denotes the characteristic function of the set $A \subset \mathbb{Z}$;
- 2. for each $\mathbf{s} = (s_n)_{n \in \mathbb{Z}} \in B$ and $m \in \mathbb{Z}$, the sequence $\mathbf{s}^m = (s_n^m)_{n \in \mathbb{Z}}$ defined by $s_n^m = s_{n+m}$ belongs to *B* and there exists N > 0 such that $\|\mathbf{s}^m\|_B \leq N \|\mathbf{s}\|_B$ for $\mathbf{s} \in B$ and $m \in \mathbb{Z}$.

We present some examples of Banach sequence spaces.

Example 2.1. The set $l^{\infty} = \{ \mathbf{s} \in S : \sup_{n \in \mathbb{Z}} |s_n| < +\infty \}$ is a Banach sequence space when equipped with the norm $\|\mathbf{s}\| = \sup_{n \in \mathbb{Z}} |s_n|$.

Example 2.2. For each $p \in [1, \infty)$, the set $l^p = \{\mathbf{s} \in S : \sum_{n \in \mathbb{Z}} |s_n|^p < +\infty\}$ is a Banach sequence space when equipped with the norm $\|\mathbf{s}\| = (\sum_{n \in \mathbb{Z}} |s_n|^p)^{1/p}$.

Example 2.3. Let $\phi: (0, +\infty) \to (0, +\infty]$ be a nondecreasing nonconstant left-continuous function. We set $\psi(t) = \int_0^t \phi(s) \, ds$ for $t \ge 0$. Moreover, for each $\mathbf{s} \in \mathcal{S}$, let $M_{\phi}(\mathbf{s}) = \sum_{n \in \mathbb{Z}} \psi(|s_n|)$. Then

$$B = \{ \mathbf{s} \in \mathcal{S} : M_{\phi}(c\mathbf{s}) < +\infty \text{ for some } c > 0 \}$$

is a Banach sequence space when equipped with the norm

$$\|\mathbf{s}\| = \inf\{c > 0 : M_{\phi}(\mathbf{s}/c) \le 1\}.$$

We need the following auxiliary results.

Proposition 2.4. Let B be an admissible Banach sequence space.

- 1. If $\mathbf{s}^1 = (s_n^1)_{n \in \mathbb{Z}}$ and $\mathbf{s}^2 = (s_n^2)_{n \in \mathbb{Z}}$ are sequences in S and $s_n^1 = s_n^2$ for all but finitely many $n \in \mathbb{Z}$, then $\mathbf{s}^1 \in B$ if and only if $\mathbf{s}^2 \in B$.
- 2. If $\mathbf{s}^n \to \mathbf{s}$ in B when $n \to \infty$, then $s_m^n \to s_m$ when $n \to \infty$, for $m \in \mathbb{Z}$.
- *3. For each* $\mathbf{s} \in B$ *and* $\lambda \in (0, 1)$ *, the sequences* \mathbf{s}^1 *and* \mathbf{s}^2 *defined by*

$$s_n^1 = \sum_{m \ge 0} \lambda^m s_{n-m}$$
 and $s_n^2 = \sum_{m \ge 1} \lambda^m s_{n+m}$

are in B, and

$$\|\mathbf{s}^1\|_B \leq \frac{N}{1-\lambda} \|\mathbf{s}\|_B \quad and \quad \|\mathbf{s}^2\|_B \leq \frac{N\lambda}{1-\lambda} \|\mathbf{s}\|_B.$$
(2.1)

Proof. 1. Assume that $\mathbf{s}^1 \in B$ and let $I \subset \mathbb{Z}$ be the finite set of all integers $n \in \mathbb{Z}$ such that $s_n^1 \neq s_n^2$. We define $\mathbf{v} = (v_n)_{n \in \mathbb{Z}}$ by $v_n = 0$ if $n \notin I$ and $v_n = s_n^2 - s_n^1$ if $n \in I$. Since *B* is an admissible Banach sequence space, we have $\mathbf{v} \in B$ and thus $\mathbf{s}^2 = \mathbf{s}^1 + \mathbf{v} \in B$.

2. We have

$$|s_m^n - s_m|\chi_{\{m\}}(k) \le |s_k^n - s_k|$$

for $k \in \mathbb{Z}$ and $n \in \mathbb{N}$. By the definition of a normed sequence space, we obtain

$$|s_m^n - s_m| \le \frac{N}{\|\chi_{\{0\}}\|_B} \|s^n - s\|_B$$

for $n \in \mathbb{Z}$ and the conclusion follows.

3. We define a sequence $\mathbf{v} = (v_n)_{n \in \mathbb{Z}}$ by $v_n = |s_n|$ for $n \in \mathbb{Z}$. Clearly, $\mathbf{v} \in B$ and $\|\mathbf{v}\|_B = \|\mathbf{s}\|_B$. Moreover,

$$\sum_{m\geq 0}\lambda^m\|\mathbf{v}^{-m}\|_B\leq N\sum_{m\geq 0}\lambda^m\|\mathbf{v}\|_B=rac{N}{1-\lambda}\|\mathbf{s}\|_B<+\infty.$$

Since *B* is complete, the series $\sum_{m\geq 0} \lambda^m \mathbf{v}^{-m}$ converges to some sequence $\mathbf{x} = (x_n)_{n\in\mathbb{Z}} \in B$. It follows from the second property that

$$x_n = \sum_{m \ge 0} \lambda^m |s_{n-m}|$$

for $n \in \mathbb{Z}$. Since $|s_n^1| \le |x_n|$ for $n \in \mathbb{Z}$, we conclude that $\mathbf{s}^1 \in B$ and $\|\mathbf{s}^1\|_B \le \|\mathbf{x}\|_B$, which yields that the first inequality in (2.1) holds. One can show in a similar manner that $\mathbf{s}^2 \in B$ and that the second inequality in (2.1) holds.

Now let $(X, \|\cdot\|)$ be a Banach space and let $\|\cdot\|_n$, for $n \in \mathbb{Z}$, be a sequence of norms on X such that $\|\cdot\|_n$ is equivalent to $\|\cdot\|$ for each $n \in \mathbb{Z}$. For an admissible space B, let

$$Y_B = \big\{ \mathbf{x} = (x_n)_{n \in \mathbb{Z}} \subset X : (\|x_n\|_n)_{n \in \mathbb{Z}} \in B \big\}.$$

For $\mathbf{x} \in Y_B$, we define

$$\|\mathbf{x}\|_{Y_B} = \|(\|x_n\|_n)_{n\in\mathbb{Z}}\|_B.$$

Proposition 2.5. $(Y_B, \|\cdot\|_{Y_B})$ is a Banach space.

Proof. Let $(\mathbf{x}^k)_{k \in \mathbb{N}}$ be a Cauchy sequence in Y_B . Repeating arguments in the proof of Proposition 2.4, one can show that $(x_n^k)_{k \in \mathbb{N}}$ is a Cauchy sequence in X for each $n \in \mathbb{Z}$. Let

$$x_n = \lim_{k \to \infty} x_n^k \quad \text{for } n \in \mathbb{Z}$$

and let $\mathbf{s}^k = (||x_n^k||_n)_{n \in \mathbb{Z}} \in B$ for $k \in \mathbb{N}$. Since

$$|||x_n^k||_n - ||x_n^l||_n| \le ||x_n^k - x_n^l||_n$$
 for $n \in \mathbb{Z}$,

we conclude that

$$\|\mathbf{s}^k - \mathbf{s}^l\|_B \le \|\mathbf{x}^k - \mathbf{x}^l\|_{Y_B}$$
 for $k, l \in \mathbb{N}$.

Hence, $(\mathbf{s}^k)_{k \in \mathbb{N}}$ is a Cauchy sequence in *B*. Since *B* is complete, it follows from property 2 in Proposition 2.4 that $\mathbf{s}^k \to \mathbf{s}$ in *B* when $k \to \infty$, where $s_n = ||\mathbf{x}_n||_n$ for $n \in \mathbb{Z}$. In particular, $\mathbf{x} = (x_n)_{n \in \mathbb{Z}} \in Y_B$. One can easily verify that the sequence $(\mathbf{x}^k - \mathbf{x})_{k \in \mathbb{N}}$ converges to 0 in Y_B , which implies that $(\mathbf{x}^k)_{k \in \mathbb{N}}$ converges to \mathbf{x} in Y_B .

3 Admissibility and exponential dichotomies

In this section we consider the notion of an exponential dichotomy with respect to a sequence of norms and we characterize it in terms of the invertibility of a certain linear operator.

3.1 Basic notions

Let *X* be a Banach space and let L(X) be the set of all bounded linear operators from *X* to itself. Given a sequence $(A_m)_{m \in \mathbb{Z}}$ in B(X), let

$$\mathcal{A}(n,m) = \begin{cases} A_{n-1} \cdots A_m & \text{if } n > m, \\ \text{Id} & \text{if } n = m. \end{cases}$$
(3.1)

Definition 3.1. We say that $(A_m)_{m \in \mathbb{Z}}$ admits an *exponential dichotomy* with respect to the sequence of norms $\|\cdot\|_m$ if:

1. there exist projections $P_m: X \to X$ for each $m \in \mathbb{Z}$ satisfying

$$A_m P_m = P_{m+1} A_m \quad \text{for } m \in \mathbb{Z} \tag{3.2}$$

such that each map $A_m | \ker P_m : \ker P_m \to \ker P_{m+1}$ is invertible;

2. there exist constants D > 0 and $0 < \lambda < 1 < \mu$ such that for each $x \in X$ and $n, m \in \mathbb{Z}$ we have

$$|\mathcal{A}(n,m)P_m x||_n \le D\lambda^{n-m} ||x||_m \quad \text{for } n \ge m$$
(3.3)

and

$$|\mathcal{A}(n,m)Q_mx||_n \le D\mu^{n-m} ||x||_m \quad \text{for } n \le m,$$
(3.4)

where $Q_m = \text{Id} - P_m$ and

$$\mathcal{A}(n,m) = (\mathcal{A}(m,n)|\ker P_n)^{-1}: \ker P_m \to \ker P_n$$

for n < m.

More generally, one can consider the notion of an exponential dichotomy for sequences of linear operators between different spaces. Namely, let $X_n = (X_n, \|\cdot\|)$, for $n \in \mathbb{Z}$, be pairwise isomorphic Banach spaces. Given a sequence of bounded linear operators $A_m \colon X_m \to X_{m+1}$, for $m \in \mathbb{Z}$, one can define $\mathcal{A}(n,m) \colon X_m \to X_n$ by (3.1) and introduce a corresponding notion of an exponential dichotomy, with projections $P_m \colon X_m \to X_m$ for $m \in \mathbb{Z}$. All the results obtained in this section hold verbatim in this general setting, but we prefer avoiding the cumbersome notation.

Now let *B* be a Banach sequence space. Our main aim is to characterize the notion of an exponential dichotomy with respect to a sequence of norms in terms of the invertibility of the operator $T_B: \mathcal{D}(T_B) \subset Y_B \to Y_B$ defined by

$$(T_B\mathbf{x})_n = x_n - A_{n-1}x_{n-1}, \qquad n \in \mathbb{Z},$$

on the domain $\mathcal{D}(T_B)$ formed by all vectors $\mathbf{x} \in Y_B$ such that $T_B \mathbf{x} \in Y_B$.

Proposition 3.2. The linear operator $T_B: \mathcal{D}(T_B) \subset Y_B \to Y_B$ is closed.

Proof. Let $(\mathbf{x}^k)_{k \in \mathbb{N}}$ be a sequence in $\mathcal{D}(T_B)$ converging to $\mathbf{x} \in Y_B$ such that $T_B \mathbf{x}^k$ converges to $\mathbf{y} \in Y_B$. It follows from the definition of Y_B and property 2 in Proposition 2.4 that

$$x_n - A_{n-1}x_{n-1} = \lim_{k \to \infty} (x_n^k - A_{n-1}x_{n-1}^k) = \lim_{k \to \infty} (T_B \mathbf{x}^k)_n = y_n$$

for $n \in \mathbb{Z}$, using the continuity of the linear operator A_{n-1} . Therefore, $\mathbf{x} \in \mathcal{D}(T_B)$ and $T_B \mathbf{x} = \mathbf{y}$. This shows that the operator T_B is closed.

For $\mathbf{x} \in \mathcal{D}(T_B)$ we consider the graph norm

$$\|\mathbf{x}\|'_{Y_B} = \|\mathbf{x}\|_{Y_B} + \|T\mathbf{x}\|_{Y_B}$$

Clearly, the operator

$$T_B: (\mathcal{D}(T_B), \|\cdot\|'_{Y_B}) \to (Y, \|\cdot\|_{Y_B})$$

is bounded and from now on we denote it simply by T_B . It follows from Proposition 3.2 that $(\mathcal{D}(T_B), \|\cdot\|'_{Y_B})$ is a Banach space.

3.2 Characterization of exponential dichotomies

In this section we characterize the notion of an exponential dichotomy with respect to a sequence of norms in terms of the invertibility of the operator T_B .

Theorem 3.3. If the sequence $(A_m)_{m \in \mathbb{Z}}$ admits an exponential dichotomy with respect to the sequence of norms $\|\cdot\|_m$, then the operator T_B is invertible.

Proof. In order to establish the injectivity of the operator T_B , assume that $T_B \mathbf{x} = 0$ for some $\mathbf{x} \in Y_B$. Then $x_n = A_{n-1}x_{n-1}$ for $n \in \mathbb{Z}$. Let $x_n^s = P_n x_n$ and $x_n^u = Q_n x_n$. We have $x_n = x_n^s + x_n^u$ and it follows from (3.2) that

$$x_n^s = A_{n-1} x_{n-1}^s$$
 and $x_n^u = A_{n-1} x_{n-1}^u$

for $n \in \mathbb{Z}$. Moreover, $x_k^s = \mathcal{A}(k, k - m) x_{k-m}^s$ for $m \ge 0$ and hence,

$$\begin{aligned} \|x_k^{s}\|_k &= \|\mathcal{A}(k,k-m)x_{k-m}^{s}\|_k \\ &= \|\mathcal{A}(k,k-m)P_{k-m}x_{k-m}\|_k \\ &\leq D\lambda^m \|x_{k-m}\|_{k-m} \\ &\leq \frac{DN}{\alpha_B}\lambda^m \|\mathbf{x}\|_{Y_B}, \end{aligned}$$

where $\alpha_B = \|\chi_{\{0\}}\|_B$. Letting $m \to \infty$ in the last term yields that $x_k^s = 0$ for $k \in \mathbb{Z}$. Similarly, $x_k^u = \mathcal{A}(k, k+m) x_{k+m}^u$ for $m \ge 0$ and hence,

$$\begin{split} \|x_{k}^{u}\|_{k} &= \|\mathcal{A}(k,k+m)x_{k+m}^{u}\|_{k} \\ &= \|\mathcal{A}(k,k+m)Q_{k+m}x_{k+m}\|_{k} \\ &\leq D\mu^{-m}\|x_{k+m}\|_{k+m} \\ &\leq \frac{DN}{\alpha_{R}}\mu^{-m}\|\mathbf{x}\|_{Y_{B}}. \end{split}$$

Therefore, $x_k^u = 0$ for $k \in \mathbb{Z}$ and hence $\mathbf{x} = 0$. This shows that the operator T_B is injective.

Now we show that T_B is onto. Take $\mathbf{y} = (y_n)_{n \in \mathbb{Z}} \in Y_B$. For each $n \in \mathbb{Z}$, let

$$x_n^1 = \sum_{m \ge 0} \mathcal{A}(n, n-m) P_{n-m} y_{n-m}$$

and

$$x_n^2 = -\sum_{m\geq 1} \mathcal{A}(n, n+m) Q_{n+m} y_{n+m}.$$

We have

$$\|x_n^1\|_n \le \sum_{m\ge 0} D\lambda^m \|y_{n-m}\|_{n-m}$$
 and $\|x_n^2\|_n \le \sum_{m\ge 1} D\mu^{-m} \|y_{n+m}\|_{n+m}.$

It follows from property 3 in Proposition 2.4 that $(x_n^1)_{n \in \mathbb{Z}}$ and $(x_n^2)_{n \in \mathbb{Z}}$ belong to Y_B . Now let $x_n = x_n^1 + x_n^2$ for $n \in \mathbb{Z}$ and $\mathbf{x} = (x_n)_{n \in \mathbb{Z}}$. Then $\mathbf{x} \in Y_B$ and one can easily verify that $T_B \mathbf{x} = \mathbf{y}$. This completes the proof of the theorem.

Now we establish the converse of Theorem 3.3.

Theorem 3.4. If the operator T_B is bijective, then the sequence $(A_m)_{m \in \mathbb{Z}}$ admits an exponential dichotomy with respect to the sequence of norms $\|\cdot\|_m$.

Proof. For each $n \in \mathbb{Z}$, let X(n) be the set of all $x \in X$ with the property that there exists a sequence $\mathbf{x} = (x_m)_{m \in \mathbb{Z}} \in Y_B$ such that $x_n = x$ and $x_m = A_{m-1}x_{m-1}$ for m > n. Moreover, let Z(n) be the set of all $x \in X$ for which there exists $\mathbf{z} = (z_m)_{m \in \mathbb{Z}} \in Y_B$ such that $z_n = x$ and $z_m = A_{m-1}z_{m-1}$ for $m \le n$. One can easily verify that X(n) and Z(n) are subspaces of X.

Lemma 3.5. *For each* $n \in \mathbb{Z}$ *, we have*

$$X = X(n) \oplus Z(n). \tag{3.5}$$

Proof of the lemma. Given $v \in X$, we define a sequence $\mathbf{y} = (y_m)_{m \in \mathbb{Z}}$ by $y_n = v$ and $y_m = 0$ for $m \neq n$. Clearly, $\mathbf{y} \in Y_B$. Hence, there exists $\mathbf{x} \in Y_B$ such that $T_B \mathbf{x} = \mathbf{y}$, that is,

$$x_n - A_{n-1} x_{n-1} = v (3.6)$$

and

$$x_{m+1} = A_m x_m \quad \text{for } m \neq n-1.$$
 (3.7)

Since $\mathbf{x} \in Y_B$, we obtain

 $x_n \in X(n)$ and $A_{n-1}x_{n-1} \in Z(n)$.

Moreover, by (3.6), we have $v \in X(n) + Z(n)$.

Now take $v \in X(n) \cap Z(n)$ and choose $\mathbf{x} = (x_m)_{m \in \mathbb{Z}}$ and $\mathbf{z} = (z_m)_{m \in \mathbb{Z}}$ in Y_B such that $x_n = z_n = v$,

$$x_m = A_{m-1} x_{m-1} \quad \text{for } m > n$$

and

$$z_m = A_{m-1} z_{m-1}$$
 for $m \le n$

We define $\mathbf{y} = (y_m)_{m \in \mathbb{Z}}$ by $y_m = x_m$ for $m \ge n$ and $y_m = z_m$ for m < n. It is easy to verify that $\mathbf{y} \in Y_B$ and $T_B \mathbf{y} = 0$. Since T_B is invertible, we have $\mathbf{y} = 0$ and thus $y_n = v = 0$.

Let P_n : $X \to X(n)$ and Q_n : $X \to Z(n)$ be the projections associated to the decomposition in (3.5).

Lemma 3.6. Property (3.2) holds.

Proof of the lemma. It is sufficient to show that

$$A_n X(n) \subset X(n+1)$$
 and $A_n Z(n) \subset Z(n+1)$

for $n \in \mathbb{Z}$. Take $v \in X(n)$ and $\mathbf{x} = (x_m)_{m \in \mathbb{Z}} \in Y_B$ such that $x_n = v$ and

$$x_m = A_{m-1} x_{m-1}$$
 for $m > n$.

Then $x_{n+1} = A_n v \in X(n+1)$. Now take $v \in Z(n)$ and choose $\mathbf{z} = (z_m)_{m \in \mathbb{Z}}$ such that $z_n = v$ and $z_m = A_{m-1}z_{m-1}$ for $m \leq n$. We define $\mathbf{z}' = (z'_m)_{m \in \mathbb{Z}}$ by $z'_m = z_m$ for $m \neq n+1$ and $z_{n+1} = A_n v$. Since $\mathbf{z}' \in Y_B$ and

$$z'_{m} = A_{m-1} z'_{m-1}$$
 for $m \le n+1$,

we conclude that $A_n v \in Z(n+1)$.

Lemma 3.7. The linear operator $A_n | \ker P_n : \ker P_n \to \ker P_{n+1}$ is invertible for each $n \in \mathbb{Z}$.

Proof of the lemma. We first establish the injectivity of the operator. Assume that $A_n v = 0$ for $v \in \ker P_n = Z(n)$ and choose $\mathbf{z} = (z_m)_{m \in \mathbb{Z}} \in Y_B$ such that $z_n = v$ and

$$z_m = A_{m-1} z_{m-1}$$
 for $m \le n$.

Moreover, we define $\mathbf{y} = (y_m)_{m \in \mathbb{Z}}$ by $y_m = 0$ for m > n and $y_m = z_m$ for $m \le n$. Clearly, $\mathbf{y} \in Y_B$ and $T_B \mathbf{y} = 0$. Since T_B is invertible, we conclude that $\mathbf{y} = 0$ and thus $y_n = v = 0$.

In order to show that the operator is onto, take $v \in \ker P_{n+1} = Z(n+1)$ and $\mathbf{z} = (z_m)_{m \in \mathbb{Z}} \in Y_B$ with $z_{n+1} = v$ and $z_m = A_{m-1}z_{m-1}$ for $m \leq n+1$. Clearly, $z_n \in Z(n)$ and $A_n z_n = z_{n+1}$. This shows that $A_n | \ker P_n$ is onto.

Now we establish exponential bounds. Take $n \in \mathbb{Z}$ and $v \in X$. Moreover, let **y** and **x** be as in the proof of Lemma 3.5. For each $z \ge 1$, we define a linear operator

$$B(z)\colon (\mathcal{D}(T_B), \|\cdot\|'_{Y_B}) \to (Y_B, \|\cdot\|_{Y_B})$$

by

$$(B(z)\nu)_m = \begin{cases} z\nu_m - A_{m-1}\nu_{m-1} & \text{if } m \le n, \\ \frac{1}{z}\nu_m - A_{m-1}\nu_{m-1} & \text{if } m > n. \end{cases}$$

We have $B(1) = T_B$ and

$$\|(B(z) - T_B)\boldsymbol{\nu}\|_{Y_B} \le (z-1)\|\boldsymbol{\nu}\|'_{Y_B}$$

for $\nu \in \mathcal{D}(T_B)$ and $z \ge 1$. In particular, this implies that B(z) is invertible whenever $1 \le z < 1 + 1/\|T_B^{-1}\|$, and

$$||B(z)^{-1}|| \le \frac{1}{||T_B^{-1}||^{-1} - (z-1)}$$

Take t = 1/z for a given $z \in (1, 1 + 1/||T_B^{-1}||)$ and let $\mathbf{z} \in Y_B$ be the unique element such that $B(1/t)\mathbf{z} = \mathbf{y}$. Writing

$$D' = \frac{1}{\|T_B^{-1}\|^{-1} - (1/t - 1)},$$

we obtain

$$\|\mathbf{z}\|_{Y_B} \le \|\mathbf{z}\|'_{Y_B} = \|B(1/t)^{-1}\mathbf{y}\|'_{Y_B} \ \le D'\|\mathbf{y}\|_{Y_B} = ND'lpha_B\|v\|_n$$

(where $\alpha_B = \|\chi_{\{0\}}\|_B$). For each $m \in \mathbb{Z}$, let $x_m^* = t^{|m-n|-1}z_m$ and $\mathbf{x}^* = (x_m^*)_{m \in \mathbb{N}}$. Clearly, $\mathbf{x}^* \in Y_B$. One can easily verify that $T_B \mathbf{x}^* = \mathbf{y}$ and hence $\mathbf{x}^* = \mathbf{x}$. Thus,

$$\|x_{m}\|_{m} = \|x_{m}^{*}\|_{m} = t^{|m-n|-1} \|z_{m}\|_{m}$$

$$\leq \frac{N}{\alpha_{B}} t^{|m-n|-1} \|\mathbf{z}\|_{Y_{B}} \leq \frac{N^{2}D'}{t} t^{|m-n|} \|v\|_{n}$$
(3.8)

for $m \in \mathbb{Z}$. Moreover, it was shown in the proof of Lemma 3.5 that $P_n v = x_n$ and $Q_n v = -A_{n-1}x_{n-1}$. Hence, it follows from (3.7) and (3.8) that

$$\|\mathcal{A}(m,n)P_{n}v\|_{m} = \|\mathcal{A}(m,n)x_{n}\|_{m} = \|x_{m}\|_{m}$$

$$\leq \frac{N^{2}D'}{t}t^{m-n}\|v\|_{n}$$
(3.9)

for $m \ge n$. Similarly, it follows from (3.7) and (3.8) that

$$\|\mathcal{A}(m,n)Q_nv\|_m \le \frac{N^2 D'}{t} t^{n-m} \|v\|_n$$
(3.10)

for m < n. By (3.9) and (3.10), there exists D > 0 such that (3.3) and (3.4) hold taking $\lambda = t$ and $\mu = 1/t$. This completes the proof of the theorem.

4 Nonuniformly hyperbolic sets

Now we consider an elaboration of the situation considered in Section 3. Namely, we characterize the notion of a nonuniformly hyperbolic set in terms of the invertibility of certain linear operators. More precisely, to each trajectory $f^n(x)$ of a nonuniformly hyperbolic set of a diffeomorphism f one can associate a linear operator defined in terms of the sequence of tangent spaces $d_{f^n(x)}f$ (see the discussion after Definition 3.1). Moreover, each trajectory admits an exponential dichotomy with respect to the same sequence of tangent spaces and so it is natural to use arguments that are an elaboration of those in the former section.

4.1 Basic notions

Let *M* be a compact Riemannian manifold and let $f: M \to M$ be a C^1 diffeomorphism.

Definition 4.1. An *f*-invariant measurable set $\Lambda \subset M$ is said to be *nonuniformly hyperbolic* if there exist constants $0 < \lambda < 1 < \mu$ and a *df*-invariant splitting

$$T_x M = E^s(x) \oplus E^u(x)$$

for $x \in \Lambda$ such that given $\varepsilon > 0$, there exist measurable functions $C, K \colon \Lambda \to \mathbb{R}^+$ such that for each $x \in \Lambda$:

1. for $v \in E^s(x)$ and $n \ge 0$,

$$\|d_{x}f^{n}v\|_{f^{n}(x)} \leq C(x)\lambda^{n}e^{\varepsilon n}\|v\|_{x};$$
(4.1)

2. for $v \in E^u(x)$ and $n \ge 0$,

$$\|d_{x}f^{-n}v\|_{f^{-n}(x)} \leq C(x)\mu^{-n}e^{\varepsilon n}\|v\|_{x};$$
(4.2)

3.

$$\angle (E^s(x), E^u(x)) \ge K(x); \tag{4.3}$$

4. for $n \in \mathbb{Z}$,

$$C(f^{n}(x)) \leq C(x)e^{\varepsilon|n|} \quad \text{and} \quad K(f^{n}(x)) \geq K(x)e^{-\varepsilon|n|}.$$
(4.4)

We note that a nonuniform hyperbolic set gives rise naturally to a parameterized family of exponential dichotomies with respect to a sequence of norms. More precisely, to each trajectory one can associate an exponential dichotomy (see [2]).

Proposition 4.2. Let $\Lambda \subset M$ be a nonuniformly hyperbolic set. Then for each $\varepsilon > 0$ such that $\lambda e^{\varepsilon} < 1 < \mu e^{-\varepsilon}$ there exists a norm $\|\cdot\|' = \|\cdot\|^{\varepsilon}$ on $T_{\Lambda}M$ such that for each $x \in \Lambda$ the sequence of linear operators

 $A_n = d_{f^n(x)}f \colon T_{f^n(x)}M \to T_{f^{n+1}(x)}M$

admits an exponential dichotomy with respect to the norms $\|\cdot\|'_{f^n(x)}$.

Alternatively, Proposition 4.2 can be obtained as a consequence of the proof of Theorem 4.3 below (the proof introduces a particular norm that is also adapted to our characterization of nonuniformly hyperbolic sets).

4.2 Characterization of nonuniformly hyperbolic sets

Given an admissible Banach sequence space *B* and a norm $\|\cdot\|'$ on the tangent bundle $T_{\Delta}M$, for each $x \in \Lambda$ we denote by Y_x the set of all sequences $\mu = (\mu_n)_{n \in \mathbb{Z}}$ with $\mu_n \in T_{x_n}M$, where $x_n = f^n(x)$, such that $(\|\mu_n\|'_{x_n})_{n \in \mathbb{Z}} \in B$. One can easily verify that Y_x is a Banach space with the norm

$$\|\boldsymbol{\mu}\| = \|(\|\mu_n\|'_{x_n})_{n\in\mathbb{Z}}\|_{B^{1}}$$

Finally, we define a linear operator R_x by

$$(R_x\boldsymbol{\mu})_n = \mu_n - d_{x_{n-1}}f\mu_{n-1}, \qquad n \in \mathbb{Z},$$

on the domain formed by all $\mu = (\mu_n)_{n \in \mathbb{Z}} \in Y_x$ such that $R_x \mu \in Y_x$.

Theorem 4.3. Let $\Lambda \subset M$ be a nonuniformly hyperbolic set and let B be an admissible Banach sequence space. Then there exists $\varepsilon_0 > 0$ such that for every $\varepsilon \in (0, \varepsilon_0)$ there is a norm $\|\cdot\|' = \|\cdot\|^{\varepsilon}$ on $T_{\Lambda}M$ and a measurable function $G \colon \Lambda \to \mathbb{R}^+$ such that for each $x \in \Lambda$:

1.

$$\frac{1}{2} \|v\|_{x} \le \|v\|_{x}^{\varepsilon} \le G(x) \|v\|_{x}, \qquad v \in T_{x}M;$$
(4.5)

2.

$$G(f^{n}(x)) \le e^{2\varepsilon |n|} G(x), \qquad n \in \mathbb{Z};$$
(4.6)

- 3. $R_x: Y_x \to Y_x$ is a well defined, bounded and invertible linear operator;
- 4. there exists a constant D > 0 (independent of ε and x) such that

$$\|R_x^{-1}\| \le D. \tag{4.7}$$

Proof. Since *M* is compact and *f* is continuous, there exists A > 0 such that $||d_x f|| \le A$ and $||d_x f^{-1}|| \le A$ for $x \in M$. Without loss of generality, one may assume that $1/A \le \lambda$ and $\mu \le A$ (since otherwise one can simply increase *A*). Take $\varepsilon_0 > 0$ such that $\lambda e^{\varepsilon_0} < 1 < \mu e^{-\varepsilon_0}$. For each $\varepsilon \in (0, \varepsilon_0)$ we introduce an adapted norm $|| \cdot ||^{\varepsilon}$ on $T_{\Lambda}M$. For $v \in E^s(x)$, let

$$\|v\|_{x}^{\varepsilon} = \sup_{n\geq 0} \left(\lambda^{-n} e^{-\varepsilon n} \|d_{x}f^{n}v\|_{f^{n}(x)}\right) + \sup_{n< 0} \left(e^{\varepsilon n}A^{n} \|d_{x}f^{n}\|_{f^{n}(x)}\right).$$

It follows from (4.1) that

$$\|v\|_{x} \le \|v\|_{x}^{\varepsilon} \le (C(x)+1)\|v\|_{x} \quad \text{for } v \in E^{s}(x).$$
(4.8)

Moreover,

$$\begin{aligned} \|d_{x}fv\|_{f(x)}^{\varepsilon} &= \sup_{n \ge 0} \left(\lambda^{-n}e^{-\varepsilon n} \|d_{x}f^{n+1}v\|_{f^{n+1}(x)}\right) \\ &+ \sup_{n < 0} \left(e^{\varepsilon n}A^{n} \|d_{x}f^{n+1}v\|_{f^{n+1}(x)}\right) \\ &= \lambda e^{\varepsilon} \sup_{n \ge 0} \left(\lambda^{-(n+1)}e^{-\varepsilon(n+1)} \|d_{x}f^{n+1}v\|_{f^{n+1}(x)}\right) \\ &+ \frac{1}{A}e^{-\varepsilon} \sup_{n < 0} \left(A^{n+1}e^{\varepsilon(n+1)} \|d_{x}f^{n+1}v\|_{f^{n+1}(x)}\right) \\ &\le \lambda e^{\varepsilon} \|v\|_{x}^{\varepsilon} \end{aligned}$$
(4.9)

for $v \in E^{s}(x)$. Similarly, for $v \in E^{u}(x)$, let

$$\|v\|_{x}^{\varepsilon} = \sup_{n \le 0} \left(\mu^{-n} e^{\varepsilon n} \|d_{x} f^{n} v\|_{f^{n}(x)} \right) + \sup_{n > 0} \left(A^{-n} e^{-\varepsilon n} \|d_{x} f^{n} v\|_{f^{n}(x)} \right)$$

It follows from (4.2) that

$$\|v\|_{x} \le \|v\|_{x}^{\varepsilon} \le (C(x)+1)\|v\|_{x} \quad \text{for } v \in E^{u}(x).$$
(4.10)

Moreover,

$$\begin{aligned} \|d_{x}f^{-1}v\|_{f^{-1}(x)}^{\varepsilon} &= \sup_{n \leq 0} \left(\mu^{-n}e^{\varepsilon n} \|d_{x}f^{n-1}v\|_{f^{n-1}(x)} \right) \\ &+ \sup_{n > 0} \left(e^{-\varepsilon n}A^{-n} \|d_{x}f^{n-1}v\|_{f^{n-1}(x)} \right) \\ &= \frac{1}{\mu}e^{\varepsilon}\sup_{n \leq 0} \left(\mu^{-(n-1)}e^{\varepsilon(n-1)} \|d_{x}f^{n-1}v\|_{f^{n-1}(x)} \right) \\ &+ \frac{1}{A}e^{-\varepsilon}\sup_{n > 0} \left(e^{-\varepsilon(n-1)}A^{-(n-1)} \|d_{x}f^{n-1}v\|_{f^{n-1}(x)} \right) \\ &\leq \frac{1}{\mu}e^{\varepsilon} \|v\|_{x}^{\varepsilon} \end{aligned}$$
(4.11)

for $v \in E^u(x)$. One can show in a similar manner that

$$\|d_x fv\|_{f(x)}^{\varepsilon} \le A(e^{\varepsilon} + 1) \|v\|_x^{\varepsilon} \quad \text{for } v \in E^u(x).$$

$$(4.12)$$

For an arbitrary $v \in T_x M$, we define

$$\|v\|_x^{\varepsilon} = \max\left\{\|v^s\|_{x'}^{\varepsilon}\|v^u\|_x^{\varepsilon}\right\},$$

where $v = v^s + v^u$ with $v^s \in E^s(x)$ and $v^u \in E^u(x)$. It follows from (4.3), (4.8) and (4.10) that

$$\frac{1}{2} \|v\|_x \le \|v\|_x^{\varepsilon} \le \frac{C(x)+1}{K(x)} \|v\|_x \quad \text{for } v \in T_x M.$$

Hence, (4.5) holds taking G(x) = (C(x) + 1)/K(x). Moreover, it follows from (4.4) that (4.6) holds. Finally, it follows from (4.9) and (4.12) that

$$\|d_x fv\|_{f(x)}^{\varepsilon} \le A(e^{\varepsilon} + 1) \|v\|_x^{\varepsilon}$$

$$(4.13)$$

for $x \in \Lambda$ and $v \in T_x M$.

Now let P(x): $T_x M \to E^s(x)$ and Q(x): $T_x M \to E^u(x)$ be the projections associated to the decomposition $T_x M = E^s(x) \oplus E^u(x)$.

Lemma 4.4. There exists a constant Z > 0 (independent of ε and x) such that

$$\|P(x)v\|_{x}^{\varepsilon} \leq Z\|v\|_{x}^{\varepsilon} \quad and \quad \|Q(x)v\|_{x}^{\varepsilon} \leq Z\|v\|_{x}^{\varepsilon}$$

$$(4.14)$$

for $x \in \Lambda$ and $v \in T_x M$.

Proof of the lemma. For each $x \in \Lambda$ let

$$\gamma^{\varepsilon}_x = \inf \left\{ \|v^s + v^u\|^{\varepsilon}_x : \|v^s\|^{\varepsilon}_x = \|v^u\|^{\varepsilon}_x = 1, v^s \in E^s(x), v^u \in E^u(x) \right\}.$$

Take a vector $v \in T_x M$ such that $Pv \neq 0$ and $Qv \neq 0$, where P = P(x) and Q = Q(x). Then

$$\begin{split} \gamma_x^{\varepsilon} &\leq \left\| \frac{Pv}{\|Pv\|_x^{\varepsilon}} + \frac{Qv}{\|Qv\|_x^{\varepsilon}} \right\|_x^{\varepsilon} = \frac{1}{\|Pv\|_x^{\varepsilon}} \left\| Pv + \frac{\|Pv\|_x^{\varepsilon}}{\|Qv\|_x^{\varepsilon}} Qv \right\|_x^{\varepsilon} \\ &= \frac{1}{\|Pv\|_x^{\varepsilon}} \left\| v + \frac{\|Pv\|_x^{\varepsilon} - \|Qv\|_x^{\varepsilon}}{\|Qv\|_x^{\varepsilon}} Qv \right\|_x^{\varepsilon} \\ &\leq \frac{2\|v\|_x^{\varepsilon}}{\|Pv\|_x^{\varepsilon}} \end{split}$$

and thus,

$$\|Pv\|_x^{\varepsilon} \leq rac{2}{\gamma_x^{\varepsilon}} \|v\|_x^{\varepsilon}$$

for $v \in T_x M$. In order to estimate γ_x^{ε} , take $v^s \in E^s(x)$, $v^u \in E^u(x)$ such that $||v^s||_x^{\varepsilon} = ||v^u||_x^{\varepsilon} = 1$. It follows from (4.9), (4.11) and (4.13) (recall that $\varepsilon < \varepsilon_0$) that

$$\begin{split} \|v^{s} + v^{u}\|_{x}^{\varepsilon} &\geq \frac{1}{A(e^{\varepsilon_{0}} + 1)} \|d_{x}f(v^{s} + v^{u})\|_{f(x)}^{\varepsilon} \\ &\geq \frac{1}{A(e^{\varepsilon_{0}} + 1)} \left(\|d_{x}fv^{u}\|_{f(x)}^{\varepsilon} - \|d_{x}fv^{s}\|_{f(x)}^{\varepsilon} \right) \\ &\geq \frac{1}{A(e^{\varepsilon_{0}} + 1)} (\mu e^{-\varepsilon_{0}} - \lambda e^{\varepsilon_{0}}) \end{split}$$

and thus,

$$\gamma_x^{arepsilon} \geq rac{1}{A(e^{arepsilon_0}+1)}(\mu e^{-arepsilon_0}-\lambda e^{arepsilon_0}).$$

Therefore, (4.14) holds taking

$$Z = \frac{2A(e^{\varepsilon_0}+1)}{\mu e^{-\varepsilon_0} - \lambda e^{\varepsilon_0}}.$$

This completes the proof of the lemma.

Now take $x \in \Lambda$. It follows from (4.13) that R_x is a well defined bounded linear operator on Y_x . We first show that it is onto. Let $\mu = (\mu_n)_{n \in \mathbb{Z}} \in Y_x$. By Lemma 4.4, we have $\mu^s = (\mu_n^s)_{n \in \mathbb{Z}} \in Y_x$ and $\mu^u = (\mu_n^u)_{n \in \mathbb{Z}} \in Y_x$, where

$$\mu_n^s = P(f^n(x))\mu_n$$
 and $\mu_n^u = Q(f^n(x))\mu_n$.

For each $n \in \mathbb{Z}$, let

$$\xi_n^s = \sum_{m \ge 0} d_{x_{n-m}} f^m \mu_{n-m}^s$$

and

$$\xi_n^u = -\sum_{m\geq 1} d_{x_{n+m}} f^{-m} \mu_{n+m}^u.$$

It follows from (2.1), (4.9), (4.11) and (4.14) (since $\varepsilon < \varepsilon_0$) that $\boldsymbol{\xi}^s = (\boldsymbol{\xi}_n^s)_{n \in \mathbb{Z}}$ and $\boldsymbol{\xi}^u = (\boldsymbol{\xi}_n^u)_{n \in \mathbb{Z}}$ belong to Y_x . Moreover,

$$\|\boldsymbol{\xi}^{s}\| \leq rac{1}{1-\lambda e^{arepsilon_{0}}}Z\|\boldsymbol{\mu}\| \quad ext{and} \quad \|\boldsymbol{\xi}^{oldsymbol{u}}\| \leq rac{1}{\mu e^{-arepsilon_{0}}-1}Z\|\boldsymbol{\mu}\|$$

for $n \in \mathbb{Z}$. Therefore, $\boldsymbol{\xi} = (\xi_n)_{n \in \mathbb{Z}}$, where $\xi_n = \xi_n^s + \xi_n^u$, belongs to Y_x and

$$\|\boldsymbol{\xi}\| \le Z \left(\frac{1}{1 - \lambda e^{\varepsilon_0}} + \frac{1}{\mu e^{-\varepsilon_0} - 1}\right) \|\boldsymbol{\mu}\|.$$
(4.15)

Moreover, one can easily verify that $R_x \xi = \mu$.

Now we show that R_x is injective. Assume that $R_x \xi = 0$ for some $\xi = (\xi_n)_{n \in \mathbb{Z}} \in Y_x$. Then $\xi_n = d_{x_{n-1}}f$ for $n \in \mathbb{Z}$ and hence, $\xi_n^s = d_{x_{n-1}}f\xi_{n-1}^s$ and $\xi_n^u = d_{x_{n-1}}f\xi_{n-1}^u$ for $n \in \mathbb{Z}$. For each $k \in \mathbb{Z}$, it follows from (4.9) that

$$\|\xi_k^s\|_{x_k}^{\varepsilon} \leq (\lambda e^{\varepsilon})^m \|\xi_{k-m}^s\|_{x_{k-m}}^{\varepsilon} \leq \frac{NZ}{\alpha_B} (\lambda e^{\varepsilon_0})^m \|\boldsymbol{\xi}\|$$

for $m \ge 0$. Letting $m \to +\infty$, since $\lambda e^{\varepsilon_0} < 1$ we obtain $\xi_k^s = 0$. Similarly, $\xi_k^u = 0$ for $k \in \mathbb{Z}$ and thus $\xi = 0$. This shows that R_x is invertible. In addition, it follows from (4.15) that there exists a constant D > 0 (independent on x and ε) such that (4.7) holds. This completes the proof of the theorem.

Now we establish the converse of Theorem 4.3.

Theorem 4.5. Let $\Lambda \subset M$ be an f-invariant measurable set and let B be an admissible Banach sequence space. Assume that there exist D > 0 and $\varepsilon_0 > 0$ such that for each $\varepsilon \in (0, \varepsilon_0)$ there is a norm $\|\cdot\|^{\varepsilon}$ on $T_{\Lambda}M$ and a measurable function $G \colon \Lambda \to \mathbb{R}^+$ such that for each $x \in \Lambda$:

- 1. (4.5) and (4.6) hold;
- 2. $R_x: Y_x \to Y_x$ is a well defined bounded invertible linear operator and (4.7) holds.

Then Λ *is a nonuniformly hyperbolic set.*

Proof. Take $x \in \Lambda$ and $v \in T_x M$. We define $\mu = (\mu_n)_{n \in \mathbb{Z}}$ by $\mu_0 = v$ and $\mu_n = 0$ for $n \neq 0$. Clearly, $\mu \in Y_x$. Now take $\boldsymbol{\xi} = (\xi_n)_{n \in \mathbb{Z}} \in Y_x$ such that $R_x \boldsymbol{\xi} = \mu$. It can be written in the form

$$\xi_n = \begin{cases} d_{x_{n-1}} f \xi_{n-1}, & n \neq 0, \\ d_{x_{-1}} f_{-1} + v, & n = 0. \end{cases}$$

We will show that $v = v^s + v^u$, where $v^s = \xi_0$ and $v^u = -d_{x_{-1}}f\xi_{-1}$ is the hyperbolic splitting. For each $z \ge 1$ we define an operator B(z) on Y_x by

$$(B(z)\boldsymbol{\nu})_m = \begin{cases} z\nu_m - d_{x_{m-1}}f\nu_{m-1} & \text{if } m \le 0, \\ \frac{1}{z}\nu_m - d_{x_{m-1}}f\nu_{m-1}\nu_{m-1} & \text{if } m > 0. \end{cases}$$

Clearly,

$$||(B(z) - R_x)\nu|| \le (z - 1)||\nu||$$

for $\nu \in Y_x$ and $z \ge 1$. Therefore, B(z) is invertible whenever $1 \le z < 1 + 1/D$, and

$$||B(z)^{-1}|| \le \frac{1}{D^{-1} - (z-1)}$$

Now take $\lambda \in (0, 1)$ (independently on ε) such that $\lambda^{-1} < 1 + 1/D$ and take $\xi^* \in Y_x$ such that $B(\lambda^{-1})\xi^* = \mu$. Writing

$$D' = \frac{1}{D^{-1} - (\lambda^{-1} - 1)},$$

we obtain

$$\|\boldsymbol{\xi}^*\| = \|B(\lambda^{-1})^{-1}\boldsymbol{\mu}\| \le D'\|\boldsymbol{\mu}\| = D'\alpha_B\|v\|_x^{\varepsilon}.$$

For each $m \in \mathbb{Z}$, let $\overline{\xi}_m = \lambda^{|m|-1} \xi_m^*$ and $\overline{\xi} = (\overline{\xi}_m)_{m \in \mathbb{Z}}$. Clearly, $\overline{\xi} \in Y_x$. Moreover, one can easily verify that $R_x \overline{\xi} = \mu$ and hence $\overline{\xi} = \xi$. Thus,

$$\|\xi_m\|_{x_m}^{\varepsilon} = \|\overline{\xi}_m\|_{x_m}^{\varepsilon} = \lambda^{|m|-1} \|\xi_m^*\|_{x_m}^{\varepsilon} \le D'N\lambda^{|m|-1} \|v\|_x^{\varepsilon}$$

for $m \in \mathbb{Z}$. Finally, it follows from (4.5) that

$$\|d_x f^m v^s\| \le C(x)\lambda^m \|v\|$$
 and $\|d_x f^{-m} v^u\| \le C(x)\lambda^m \|v\|$

for $m \ge 1$, where $C(x) = 2D'NG(x)\lambda^{-1}$.

Now let $E^s(x)$ and $E^u(x)$ be the sets, respectively, of all vectors v^s and v^u constructed above. These are df-invariant subspaces of $T_x M$ and are uniquely defined (and so independent of ε). Indeed, take $v \in T_x M$ and let $v = v^s + v^u$ with $v^s \in E^s(x)$ and $v^u \in E^u(x)$. We define $\mu = (\mu_n)_{n \in \mathbb{Z}}$ by $\mu_0 = d_x f v$ and $\mu_n = 0$ for $n \neq 0$. Clearly, $\mu \in Y_{f(x)}$. Moreover, we define $\boldsymbol{\xi} = (\xi_n)_{n \in \mathbb{Z}}$ by $\xi_n = d_x f^{n+1} v^s$ for $n \ge 0$ and $\xi_n = -d_x f^{n+1} v^u$ for n < 0. Then $\boldsymbol{\xi} \in Y_{f(x)}$ (this is a consequence of the fact that the sequence $\boldsymbol{\xi}$ constructed above belongs to Y_x). Finally, it is easy to check that $R_{f(x)}\boldsymbol{\xi} = \boldsymbol{\mu}$. This implies that

$$\xi_0 = d_x f v^s \in E^s(f(x))$$
 and $-d_x f \xi_{-1} = d_x f v^u \in E^u(f(x))$

is the hyperbolic splitting of $d_x f v$ and so the decomposition is df-invariant.

We have

$$\|v^s\|_x^arepsilon = \|\xi_0\|_x^arepsilon \leq rac{1}{lpha_B}\|oldsymbol{\xi}\| \leq rac{D}{lpha_B}\|oldsymbol{\mu}\| = D\|v\|_x^arepsilon$$

and thus,

$$\|v^u\|_x^\varepsilon = \|v - v^s\|_x^\varepsilon \le \|v\|_x^\varepsilon + \|v^s\|_x^\varepsilon \le (1+D)\|v\|_x^\varepsilon$$

By (4.5), we obtain

$$\|v^s\|_x \le rac{1}{K(x)} \|v\|_x$$
 and $\|v^u\|_x \le rac{1}{K(x)} \|v\|_x$,

where K(x) = 1/((2+2D)G(x)). It follows readily from (4.6) that the functions *C* and *K* satisfy (4.4) with ε replaced by 2ε . This shows that the set Λ is nonuniformly hyperbolic.
