Y. Friedman and B. Russo [*J. Reine Angew. Math.* **356** (1985), 67–89; [MR0779376 \(86f:46073\)](#)] described the central decomposition of a JBW\*-triple into its atomic and non-atomic parts. The interesting paper under review is mainly concerned with proving the corresponding result for real JBW\*-triples.
