

GENERAL TERMS AND CONDITIONS

Registration without accommodation: 50.000 Ft or 140 €

The participation fee includes: participation in the scientific and social programmes, the book of abstracts, a certificate of attendance on request.

Registration with accommodation: 60.000 Ft or 170 €

The participation fee includes: participation in the scientific and social programmes, the book of abstracts, a certificate of attendance on request and the 2 nights accommodation in a 3 bedded dormitory room.

By registering and giving the billing information you're going to receive an invoice. If you need a proform invoice please indicate it!

Payment is possible only by transfer.

All bank charges must be born by the transferring party.

The (proform) invoice for the payment of the registration fee will be sent to the participant (and the cost bearer if given) by e-mail after the processing of the application, the latest within 14 working days of the application.

The bank details for the transfer and the information to be indicated in the communication box will also be included.

If your costs are paid by your employer or sponsor, please indicate the billing name and address accurately on the application form and provide a contact person and the contact details!

If you paid on the basis of a proform invoice, an advance and final invoice will be issued based on the bank statement in accordance with the legislation in force at the time, which will be sent by e-mail to the payer/sponsor's email address.

By completing the application form, a contract is concluded between the Customer and the Service Provider, whereby the Service Provider agrees to provide the confirmed services and the Customer undertakes to pay the financial amount for the services in the manner and at the time indicated on the invoice sent.

Any individual billing request should be made in writing (ugyvitel@ttikatehetsegekert.hu) at the time of registration or no later than the day before the deadline of payment.

Final invoices issued after the completion of the event (date of completion is the last day of the event) can only be cancelled on formal request and a new invoice issued after payment of an administration fee of HUF 5,000.

The payment deadline for the modified invoice is 8 days from the date of issue of the new invoice.

It is possible to cancel an invoice and issue a new invoice without any reimbursement of costs in the case of invoices issued due to an administrative error by "TTIK a Tehetségekért Alapítvány".

PAYMENT TERM

The participation fee and the service(s) ordered shall be paid on the basis of the (proform) invoice sent after the application by the indicated payment deadline (due date) to the bank account number indicated thereon, at the latest by 15 June 2026". Cancellation deadline: 15 June 2026.

CANCELLATION & MODIFICATION CONDITIONS

Cancellation of the application is only possible in writing to csm@server.math.u-szeged.hu in case of CSM 2026 or to cscs@inf.u-szeged.hu in case of CSCS 2026.

Absence without cancellation (NO SHOW):

Orders for services, printing materials, accommodation required for the organisation of the event cannot be changed by the organisers after the deadline. For this reason, the organisers will not be able to cancel the payment of dormitory rooms ordered but not used.
